### Authorization for Burial at Sea of Cremated Remains

I/We hereby authorize the Company to dispose of cremated remains of the Deceased at sea within 3 miles off coast of Ocean City/ Absecon Island.

I/We hereby-direct Steelmantown Cemetery to disseminate said cremated remains at sea, in accordance with State and Federal Law.

If no specific instructions are provided herein, Burial at Sea will be performed by Steelmantown Cemetery in a timely manner, weather permitting, between the months of April and October, or as soon as is possible.

Dissemination consists of the scattering of cremated remains at sea. I/We understand that once the cremated remains of the Deceased are disseminated, they are unrecoverable.

Unless otherwise specifically provided for herein, once dissemination of cremated remains of the Deceased has been performed, Steelmantown Cemetery reserves the right, at its sole discretion, to dispose of the container, which contained said cremated remains. The obligation of Steelmantown Cemetery shall be limited to the disposal of the cremated remains as directed herein. I/We agree to release and hold the Company, its affiliates and their agents, employees, successors and assigns harmless from any and all loss, damage, liability or causes of action (including attorney's fee and expenses of litigation) in connection with the disposal of the cremated remains of the Deceased as authorized herein or respect to the Identification of said cremated remains as being those of the Deceased.
